

The Global Fund's engagement in the G20 Process

- Since 2019, The Global Fund is a member of the G20 Health Working Group and can input into the Outcome documents and the G20 Health Ministerial Declaration.
- In July, the Global Fund has been invited by the Italian Presidency to join the Health & Finance Informal Group to input into the background document and communiqué for the joint Health and Finance Ministerial to be held on 29/30 October 2021.
 - HLIP recognized the role of the Global Fund in pandemic preparedness based on our role in strengthening health systems preparedness and in the COVID-19 response.

The Global Fund was created to fight pandemics. It is a proven & effective vehicle to channel investments to respond to & prepare for infectious disease pandemics in LMICs

Push for an integrated approach to pandemic preparedness & response that includes the fight against existing (HTM) & future pandemics

Building back better and economic recovery will depend on sustainable investments in global health especially SDG 3 targets on HTM, and PPR 4

Highlight the importance of community engagement and gender and human rights principles in effective global health investment

5

Push for equitable access and scale up of prevention/ detection/ treatment interventions, including new technology and innovation

6

The Global Fund is one of the key actors that are working together in complementarity on global health & PPR

7

Recognition of the results achieved by the Global Fund partnership in the last 20 years & the efficiency of the Global Fund model

2020 – G20 Health Ministerial Declaration (Saudi Arabia)

Health priorities: Value-based healthcare

We also recognize that, in many countries, the fight against COVID-19 will leverage its resources used to fight other endemic diseases. We encourage sustainable funding of these existing programs and efficient use of resources at country-level.

We commit to further support countries with weaker health systems in the fight against COVID-19. G20 should ensure that COVID-19 does not threaten gains made in reaching SDG 3, including health systems strengthening, surveillance for emerging infectious diseases, and the important mission of tackling other infectious and neglected tropical diseases. We acknowledge the role played by the Global Fund to Fight AIDS, Tuberculosis, and Malaria in supporting countries to mitigate the risk of COVID-19 derailing progress on HIV, TB and malaria and encourage the Global Fund to continue using funding flexibilities to support COVID-19 responses in countries.

2019 G20 Health Ministerial Declaration (Japan)

Health priorities: UHC, UHC financing, AMR, Ageing

We reaffirm our commitment to end the epidemics of AIDS, tuberculosis and malaria, and encourage all countries and stakeholders to strengthen their efforts to achieve the related SDG targets. We reaffirm the commitments made at the United Nations General Assembly (UNGA) High-Level Meeting on the Fight against Tuberculosis held on 26th September 2018. We welcome the success of 6th replenishment of the Global Fund to Fight AIDS, Tuberculosis and Malaria (Global Fund) that took place in Lyon, France on 9th and 10th October 2019

2019 Leaders Communiqué - Osaka

We reaffirm our commitment to eradicate polio as well as to end the epidemics of AIDS, tuberculosis and malaria and look forward to the success of the sixth replenishment of the Global Fund to fight AIDS, Tuberculosis, and Malaria.

2018 – G20 Health Ministerial Declaration (Argentina)

Health priorities: AMR, Child obesity, People-centered PHC, Health Systems responsiveness to disasters, catastrophes and pandemics

We recognize that strong public health systems are needed to tackle infectious diseases, including HIV/AIDS, TB, malaria and neglected tropical diseases.

G20 Leaders Declaration Buenos Aires

We are committed to ending HIV/AIDS, tuberculosis and malaria, and look forward to a successful 6th Replenishment of the Global Fund in 2019.

2017 – G20 Health Ministerial Declaration (Germany)

Health priorities: Safeguarding against Health Crises & crisis management, Strengthening Health Systems, AMR (based on One Health approach)

We welcome the voluntary financing to the World Bank's International Development Association (IDA) and global public private partnerships, e.g. Global Fund to Fight AIDS, Tuberculosis and Malaria (GFATM) and the Global Alliance for Vaccines and Immunisation (Gavi), for complementing domestic resources for health in order to build resilient and sustainable systems as a step towards realizing universal health coverage.

2021 - Leaders Summit, Cornwall, UK

The Global Fund referenced in relation to our role in ACT-A in support of fragile countries

We will continue and enhance our commitments to support fragile countries in dealing with the pandemic and other health challenges. This includes supporting ACT-A partners such as The Global Fund and Unitaid which have played a crucial role in delivering lifesaving medical and other supplies, including oxygen, tests, therapeutics and PPE, and assisting countries together with WHO to strengthen their health systems, build capacity, manage outbreaks and prevent disease spread. We call on the World Bank Group and the other Multilateral Development Banks (MDBs) to increase the speed of their financial support and will continue to support ACT-A in this regard.

2019 - Leaders Summit, Biarritz, France

Several Leaders reiterated that universal access to social protection and affordable quality health services with primary health care are a cornerstone. They called for further investments to strengthen health systems, with a strong focus on the replenishment of the Global Fund to Fight AIDS, Tuberculosis and Malaria. Several G7 members already announced a substantial financial contribution with a view to the Global Fund's replenishment conference, which will take place in Lyon on 9-10 October 2019, reaching more than USD 5 billion.

2018 - Leaders Summit, Charlevoix, Canada

We affirm our support for a successful replenishment of the Global Fund in 2019.

2016 - Leaders Summit, Ise-Shima, Japan

We are committed to ending AIDS, tuberculosis and malaria, working in partnership with the Global Fund (GF) and others. To this end, we fully support a successful 5th replenishment of the GF, taking the opportunity of the GF replenishment conference in Montreal in September, and call on traditional and new donors to support the replenishment.

2015 - Leaders Summit, Schloss Elmau, Germany

We fully support the ongoing work of the Global Fund to fight AIDS, Tuberculosis and Malaria and look forward to its successful replenishment in 2016 with the support of an enlarged group of donors.
