

Catalyzing investment in 1. System readiness for scale, institutionalization, and sustainability of the CHW workforce	Strengthening CHW Programming: to catalyze system readiness for scale, institutionalization, and sustainability of the CHW workforce.
 Community systems strengthening, particularly for community-led organizations (and networks of key and vulnerable communities). Embedding community-led monitoring (CLM) and use of CLM data for decision making. 	Accelerate CS&R for K&VP-led organizations: Incentivize investments to build operations, technical and governance capacities of CLO/CBO employing CHWs (e.g., peers) to reinforce linkage and mobilization of community health workforces, CLR and gender-transformative community systems.

Key engagement issue at country level:

Ensuring these matching funds do not go entirely to government CHW programs.

Communities must push for some of the funding to go towards building capacity of community-led groups to employ peer educators/navigators.

Proposed Way Forward

- 1. Exploring the Impact of the Catalytic Initiative a brief focusing on the stories of impact of the CI from 2020-2022.
- 2. Produce a Cost of Inaction report and/or a series of briefs that focuses on the real-world costs of not meeting the minimum 18 billion and in particular, the Catalytic Initiative.
- 3. Include stories of the Cost of Inaction: what funds are not going to be available, where will programs likely be cut, impact on multi-country grants, Matching Funds, strategic initiatives etc.
- 4. Fully Fund the catalytic investments an "ask" document with recommendations on actions the GFS and its Board should action.
