Bertrand Kampoer

Bertrand is a public health expert with special focus on health and Community Systems Strengthening, gender and human rights. Over the last five years, he has carried out more than 20 technical assistance missions in West and Central Africa to scale up TB preventive treatment, capacity building of health care providers, and sustained community engagement. In 2018, he joined the World Health Organization TB Civil Society Task Force to help translate WHO TB policies, including the End TB Strategy, into practice by integrating the views of TB affected communities and their networks at global, regional and national levels. Bertrand holds a Master in Public Health (Health Promotion) from the Faculty of Medicine, University of Lorraine, Nancy School of Public Health in France. Bertrand is the current board Chair of GCTA (Global Coalition of TB Advocate) and Coordinator of DRAF TB (www.draftb.org) a regional umbrella TB network in Francophone Africa bringing together 16 countries with more than 200 members associations of TB affected communities and survivors.

Presently, Blessina heads the Global Coalition of TB Advocates, a body that is in the forefront of ensuring a people centred and rights-based TB response.

He is the co-founder and Executive Director of the Middle East and North Africa Harm Reduction Association-MENAHRA, a regional NGO working towards promoting and advocating for harm reduction within the MENA region. President of the Regional/Arab Network Against AIDS-RANAA (2008 - 2018).

Elie has undertaken more than ten major pieces of research on HIV, drug use prevention and Harm Reduction and the role of civil society organizations.

Evaline Kibuchi

Evaline is a global health advocate with a focus on TB with over 15 years in TB advocacy. Her experience expands from advocacy for global health financing, engaging political leadership, Civil Society and communities in TB advocacy and response.

Currently she is the Chief National Coordinator, Stop TB Partnership-Kenya and advisor to the African Parliamentary TB caucus, a member of the Civil Society Task force in the WHO TB team and a board member to the International Union against TB and Lung Disease. Socios En Salud, the organization lead by Leonid, has led multiple TB regional and national interventions, highlighting his role in TB civil society strengthening. During the last decade, Socios En Salud has formed three important America's networks for TB survivors, people deprived of their liberty, and migrant population (TB Survivors Network, LAC Free TB Network, and LAC Without Borders Network); and implemented together with the Americas TB Coalition during the period 2019-2022 a TB Regional Project funded by The Global Fund (Observa TB), having created TB Social Observatories in eight LAC countries (Bolivia, Colombia, El Salvador, Guatemala, Haiti, Mexico Peru and Dominican Republic). Currently, Socios En Salud is the grantee of Stop TB Partnership for the implementation of a Regional Project funded by Challenge Facility Civil Society Initiative.

Mike Frick
